- 1. The Expo shall be governed by the rules and regulations issued by Donnell Productions.

- 5. No credits or refunds will be issued for Companies who have been given or have selected the 'Exclusive Product Line' option for their product or service.
- 6. In the event, space assigned to the Exhibitor has not been paid for by the due date, Donnell Productions may, at its full discretion terminate the agreement and reassign space to another Exhibitor. The Exhibitor is not entitled to any refund for sums paid in advance to Donnell Productions as payment for exhibit space and the Exhibitor is responsible for full payment. Credit card information on file will be used for final balance due, unless otherwise noted.
- 7. In the event, the Exhibitor does not claim or occupy their assigned space during the scheduled move-in time Donnell Productions may terminate the agreement and reassign the space. The Exhibitor is not entitled to any refund for sums paid in advance to Donnell Productions as payment for exhibit space and the Exhibitor is responsible for full payment.
- 8. Booths that are cooking or sampling food must adhere to the guidelines set by the Health Department and obtain all necessary licenses and permits.
- 9. Each Exhibitor must make provisions for safekeeping its goods from the time they are placed in the Exhibitor's booth until they are removed. Donnell Productions shall not be responsible or guarantee to the exhibitor the safety of exhibit materials against fire, theft or any loss or injury. The Exhibitor agrees to assume all liability for damage to its own goods and to the Expo facility by reason of the exhibit and shall hold harmless Donnell Productions for all liability which might ensue by reason of the exhibit and its presence at the Expo.
- 10. A \$100.00 fine shall be imposed on the Exhibitor dismantling their booth prior to closing time.
- 11. All exhibits shall be removed by the end of the scheduled move-out period unless special arrangements have been made with Donnell Productions.
